

Magic Access Acquisition Offer (“Offer”) for LCSD’s Museum Pass
Terms & Conditions

1. The Offer is valid from September 1, 2022 to August 31, 2024 (“**Promotion Period**”).
2. The Offer is only available to guests who are holders of any one type of valid Museum Passes (“**Museum Pass**”) issued by the Leisure and Cultural Services Department of HKSAR Government (“**Eligible Guests**”).
3. All Eligible Guests warrant that they have read these Terms and Conditions carefully. Each Eligible Guest signals his/her complete acceptance and full understanding of these Terms and Conditions by participating in this Offer. In the event of any dispute regarding these Terms and Conditions, conduct, results and all other matters relating to this Offer, the decision of Hongkong International Theme Parks Limited (“**HKITP**”) shall be final.
4. HKITP reserves the right to disqualify any Eligible Guest if HKITP has reasonable grounds to believe that the Eligible Guest has breached any of these Terms and Conditions. HKITP may, at its discretion with or without cause, refuse to admit any person or persons to the Hong Kong Disneyland Park (the “**Park**”) at any time.
5. Subject to these Terms and Conditions and availability, each Eligible Guest will be entitled to purchase one (1) Magic Access on the following applicable discount:
 - a) HK\$60 discount off the Published Price of any Adult Magic Access during the Promotion Period.
 - b) HK\$50 discount off the Published Price of any Child Magic Access during the Promotion Period.
 - c) HK\$50 discount off the Published Price of any Student Magic Access during the Promotion Period.
 - d) HK\$40 discount off the Published Price of any Senior Magic Access during the Promotion Period.

For the purposes of these Terms and Conditions, any Magic Access purchased under this Offer shall be referred to as “**Discounted Magic Access**”; and the price of Magic Access as published on the Hong Kong Disneyland website www.hongkongdisneyland.com (the “**Website**”) shall be known as the “**Published Price**”.

6. During the Promotion Period, each Eligible Guest may only purchase one Discounted Magic Access which will be personalized with details of the Eligible Guest. To participate in this Offer, each Eligible Guest is required to purchase his/her Discounted Magic Access personally, present his/her valid Museum Pass and such personal identification* and provide such personal data as HKITP may require at the time of purchase. The name of the Eligible Guest, the same as on Museum Pass, will be printed on the Discounted Magic Access Personalized Membership Card and the name as printed cannot be changed.

*Examples of personal identification include but are not limited to: HKID Card, passport or other photo identification (for Children aged 3 to 11: school handbook, or birth certificate and other photo identification; for full-time students aged 12 to 25: school handbook or full-time student card with photo identification).

7. All guests are required to make reservation with valid tickets or membership cards before visiting the Park. Park visit reservation of each type of ticket or membership card is subject to a limited quota. Reservation will not be accepted once the respective quota is full.
8. As required by law, all guests (except exempted persons) must use the “LeaveHomeSafe” app and fulfill the “Vaccine Pass” requirement upon entering the Park and the designated premises in the Hong Kong Disneyland Resort (“**Resort**”), and upon entering restaurants for dine-in. Please refer to the latest park visit arrangements at <https://www.hongkongdisneyland.com/guest-services/health-and-safety/>.
9. The Offer is only applicable for purchase of new Magic Access. This Offer is not applicable for purchase of Magic Access certificate, renewal and/or upgrade of any type of Magic Access. This Offer cannot be used in conjunction with other ticket promotions or discounts.
10. The Offer is only available at the ticket booths at the Main Entrance of the Park. The Offer is not available at online or other ticket sales locations.
11. HKITP reserves the right to (i) amend or supplement these terms and conditions; (ii) change the prices and validity for any tickets, tours, offers, promotions; (iii) designate or change any block-out dates and (iv) terminate or suspend the availability of any offer, discount or promotion, in each case, at any time and from time to time without prior notice.
12. This Offer and the issuance and use of Discounted Magic Access and admission to the Park or other parts of the Resort there are each subject to (i) these terms and conditions and the General Terms and Conditions at www.hongkongdisneyland.com/ticket-general-terms-conditions/, (ii) the “Magic Access Terms and Conditions” and “Magic Access Benefits Terms and Conditions” which are set out on the www.hongkongdisneyland.com/magic-access-members/ (“Member Site”); (iii) the rules and regulations applicable to the location or

facility in question (including without limitation, the Rules and Regulations of the Park) which are set out on the Website, (iv) the latest requirements at <https://www.hongkongdisneyland.com/guest-services/health-and-safety/>, and (v) all other requirements, restrictions and changes determined by HKITP in its sole discretion without advance or further notice. HKITP may from time to time, without prior notice and without refund or compensation, (a) make or modify the rules to be followed within the whole or any part of the Resort, (b) change or adjust the entry requirement or the mode of operation (including but not limited to operating hours) of the Resort or any hotel, location, attraction, shop, restaurant, facility or amenity thereat, (c) close or adjust the operation for any period the Resort or any part of it, (d) modify, relocate, refurbish or replace any location, attraction, shop, restaurant, facility or amenity; (e) restrict the number, class or eligibility of persons having access to the Resort or any part of it, (f) suspend or cancel any attraction, facility, amenity or entertainment or marketing program, offering or activity, and/or (g) impose limit on the purchase of any product or use of any service or facility, in each case due to capacity, inclement weather or special events, to ensure safety, health, security or order, or compliance with law, or if HKITP considers that the circumstances so require.

13. Discounted Magic Access is not for re-sale, non-transferable, non-refundable and non-exchangeable, either in whole or in part, for cash or any other items.
14. The Offer is made, and shall be governed by and construed, in accordance with the laws of the Hong Kong Special Administrative Region of the People's Republic of China ("HKSAR") only. The Offer may only be redeemed in the HKSAR in person by Eligible Guests at the locations specified in Sections 10 above. HKITP makes no representation that participation in this Offer is appropriate or available in other locations and this Offer is void in any jurisdiction where participation in such Offer is prohibited or restricted by law. Those who choose to participate in this Offer do so on their own initiative and are responsible for compliance with local laws, if and to the extent they are applicable.
15. These Terms and Conditions are subject to the interpretation of HKITP which shall be final and conclusive.
16. In the event of any conflict or inconsistency between the English version and the Chinese version of these Terms and Conditions, the English version shall prevail.
17. These Terms and Conditions shall be governed by and construed in accordance with the laws of the HKSAR.
18. These Terms and Conditions constitute an agreement between HKITP and the person making the purchase with HKITP in the designated sales location(s) (including the Website). A person who is not a party to this agreement shall not have any rights under the Contracts (Rights of Third Parties) Ordinance (Chapter 623 of the Laws of Hong Kong) to enforce any term of this agreement.

條款及細則

1. 此優惠適用於 2022 年 9 月 1 日至 2024 年 8 月 31 日（「優惠期」）。
2. 此優惠只適用於持有由香港特別行政區政府轄下康樂及文化事務署發出之各類有效博物館通行證（「博物館通行證」）之賓客（「合資格賓客」）。
3. 所有合資格賓客保證已經細閱此條款及細則。每位合資格賓客同時表示完全同意此條款及細則。如對此優惠有關的條款及細則及其他事宜有任何爭議，香港國際主題樂園有限公司（「本公司」）就爭議的任何問題擁有最終決定權。
4. 如本公司有合理理由相信合資格賓客違反本條款及細則，本公司保留取消其享用樂園門票優惠之權利。本公司保留酌情決定因任何原因拒絕任何人在任何時間進入香港迪士尼樂園（「樂園」）的權利。
