<u>Magic Access Acquisition Offer ("Offer") for LCSD's Museum Pass</u> <u>Terms & Conditions</u>

- 1. The Offer is valid from September 1, 2018 to August 31, 2020 ("**Promotion Period**").
- 2. The Offer is only available to guests who are holders of any one type of valid Museum Passes ("Museum Pass") issued by the Leisure and Cultural Services Department of HKSAR Government ("Eligible Guests").
- 3. All Eligible Guests warrant that they have read these Terms and Conditions carefully. Each Eligible Guest signals his/her complete acceptance and full understanding of these Terms and Conditions by participating in this Offer. In the event of any dispute regarding these Terms and Conditions, conduct, results and all other matters relating to this Offer, the decision of Hongkong International Theme Parks Limited ("**HKITP**") shall be final.

 - c) HK\$40 discount off the Published Price of any Senior Magic Access during the Promotion Period.

For the purposes of these Terms and Conditions, any Magic Access purchased under this Offer shall be referred to as "**Discounted Magic Access**"; and the price of Magic Access as published on the Hong Kong Disneyland website www.hongkongdisneyland.com (the "**Website**") shall be known as the "**Published Price**".

6. During the Promotion Period, each Eligible Guest may only purchase one Discounted Magic Access which will be personalized with details of the Eligible Guest. HKITP may from time to time, without prior notice and without refund or compensation, change the operating hours of the Park or attractions, close the Park or any part of it temporarily, restrict the number of persons having access to the Park, and/or suspend or cancel any attraction or entertainment program, due to capacity, inclement weather, special events, to ensure safety, security or order or if HKITP considers that the circumstances so require.
- 11. Discounted Magic Access is not for re-sale, non-transferable, non-refundable and non-exchangeable, either in whole or in part, for cash or any other items.
- 12. The Offer is made, and shall be governed by and construed, in accordance with the laws of the Hong Kong Special Administrative Region of the People's Republic of China ("**HKSAR**") only.
